

MEMORANDUM OF ASSOCIATION OF 'THE INSTITUTE OF THE BROTHERS OF ST.GABRIEL SOCIETY, PROVINCE OF NORTH EAST INDIA.

1. NAME:

The name of the society shall be **The Institute of the Brothers of St.Gabriel Society, Province of North-East India.**

2. ADDRESS:

The registered of the society shall be at Aizawl, Mizoram with Postal address at **St. Paul's Higher Secondary School, Montfort Hills, Aizawl-796005.**




3. OBJECTS:

The Institute of the Brothers of St.Gabriel Society, Province of North-East India, a voluntary charitable and religious organisation of men, in a spirit of Christian love and guided by the spirituality of St. Louis De Montfort, aims at the welfare and the integral development leading to wholesome physical, intellectual, psychological and spiritual growth of all persons, especially of the minority community, without the distinction of caste or creed, religion or race, or other considerations, through charitable activities in the field of formal or non-formal education, developmental activities, and community development projects by making people aware of their rights and duties as well as by developing leadership among them and help them to inculcate the value of truth justice, equality, love co-operation and brotherhood and thus liberate themselves from social evils like casteism, communalism etc, Hence the objectives of The Institute of the Brothers of St.Gabriel Society, North-East India shall specifically include the following:

- a. To provide formal, non-formal, vocational, and professional education to the children, and adults so as to facilitate all-round intellectual, moral and spiritual growth and development of human values;
- b. To promote justice and equality among the people, especially among the marginalised and oppressed in the society by creating awareness of their rights and duties and by promoting co-operative efforts among them;
- c. To serve the cause of socio-economic growth of the people of North-East India, by devising schemes,

- projects and undertakings which result in self-sufficiency, elimination of poverty and misery and enhancement of prosperity,
- d. To develop leadership qualities and spirit of voluntary service, among the students and youth of North-East India;
 - e. To foster and promote cultural and linguistic activities and to encourage skills, creative and aesthetic arts and crafts among the people of North-East India;
 - f. To channel the energies of the people towards constructive national work in social, educational and cultural fields and promote such programmes and activities aimed at national integration;
 - g. To perform works of charity to individuals, classes of persons, communities, and villages with a view of promoting human dignity and self-sufficiency;
 - h. To undertake community, village development programmes aimed at the integrated development of the community, village so as to facilitate all-round intellectual, moral, spiritual and economic growth of the people;
 - i. To administer and run institutions which shall offer appropriate facility, training and education to all who desire, of their own choice to dedicate themselves to the service of God, country and fellow being;
 - j. To diffuse social, religious, secular, scientific, cultural knowledge by conducting classes, lectures conferences, seminars, competitions, educational, training and recreation camps, or any other lawful means and give scholarships, free ships, certificates and awards;
 - k. To print, publish, and exhibit films, journals, magazines, periodicals, books, papers, pamphlets, advertisements, reports, lectures and other reading materials and pictorial matters for diffusion of useful knowledge and all other mass-contact programmes like audios, audio-visuals, and keeping with the charitable, educational, medical, and moral ideas in the promotion, spread, uplift, benefit and advancement of charitable, educational, cultural, social, moral, scientific technical and religious ideals and objects of the Society;



- l. To establish construct, maintain, endow, develop, modify and alter, manage, administer, conduct, carry on, any school or Institution, health centres, Seminary, Retreat house, Prayer house, Churches, Chapels, Ashrams, Dispensaries, Hospitals, Vocational Institutes, Literary Programme centres, Training centres, Credits unions, Colleges, Orphanages, Destitute homes, Poor houses, Hostels, Home for the Aged, libraries, reading rooms, administration centres, community halls, agricultural farms for demonstration and training, gymnasium, academy of fine arts etc.
- m. To receive gifts, endowments, bequests and donations in the form of money, property, movable or immovable in any form for the purpose of the work connected with the objects of the society;
- n. To purchase, take on lease or exchange or other wise acquire any land buildings casements or other movable or immovable property which may be acquired for the purpose of the society or to sell, dispose, lease, rent out, mortgage, give in exchange, surrender or dispose of them as the governing body of the society may be decide which shall be intimated to the registrar firms and societies for his approval.
- o. To open and operate bank accounts in the name of the society, and to invest, administer, manage, all such funds of the society along with Institutional affairs for further development of the society and also to establish and maintain reserve funds of such amounts as the governing body may think fit for the promotion of the activities of the society including the extension of buildings and structures.
- p. To subscribe, donate or aid help and assist financially or otherwise any charitable and other institutions or organisation having same or similar objects of the society, and to create and to establish form, organise, administer, control, supervise or many any trust association or organisation the object of which is not contrary to the objects of the society;
- q. To give and to borrow and to raise funds, to receive and use any gifts, donation or foundation or other movable property for all offices, duties and functions of trustees, managers and administrators,


solely or jointly with others, in respect of any such gifts, donations, and foundations, whether vested in the society or otherwise;

- r. To take such steps by personal or written appeals, public meeting or otherwise as may from time to time deemed expedient for procuring contribution for promoting the interests of the society.
- s. All income of the society from the movable or immovable properties and as per clause (e) shall be spend solely for the objectives of the society and no portion shall be distributed among its members as profits, dividends or bonus, provided however, nothing herein shall prevent the payment in good faith and bonafide remuneration to any officer, servant or member of the society for actual service rendered to the society and for maintenance and upkeep of ageing members who retire from active participation, unless mentioned otherwise.
- t. To enter into any settlement, understanding, arrangements or agreements with any government, semi-government body or such other authority or department, whether central state, district municipal or otherwise that may seem conducive to the objects of the society and to obtain from any of the above mentioned bodies such rights grants, sponsorships, concessions and privileges and to comply with such arrangements.
- u. To employ, engage, appoint, any person as manager, teacher, professor, medical and legal practitioner, superintendents, specialists, craftsmen technician, suppresser, counsellor, nurse, social worker or any other person having special or general knowledge skill, training or education or any other person or body of persons, organisations for salary, stipend, honoraria, wages, or payment in cash or kind or otherwise, for the progress or achievements of the society.
- v. To hold or conduct classes, lectures, conferences, seminars, competitions, educational training and recreation camps, and give scholarships, free ships certificates and awards as and when found necessary.
- w. To amend and alter bye-laws, consistent with the

memorandum of the association for the proper administration of the society and the Institutions under the same;

- x. And generally, to do all things and everything necessary, suitable and proper for the promotion of accomplishment of any of the purposes or objects of the society or for the furtherance of any powers set forth in these presents either alone or in the conjunction with other societies, corporations, firms or individuals, and to do every act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid business or powers or any part or parts thereof provided the same be not inconsistent with the constitutions of the society of The Institute of the Brothers of St.Gabriel Society, Province of North East India, nor the canon law of the Catholic Church, nor with the laws under which this society is organised, and subject to the provisions of these presents, the Governing body may exercise all powers of the society which are not by any law nor by these presents are required to be exercised by the president, the vice president or by the society in general meeting.
- y As the society growing and expanding its educational mission, the following institutions are added under the society:
(1)Montfort School Batabari,Abhayapuri.P.O,Assam -783 384.
(2)Montfort Secondary School,Jonglapara,Resubelpara.P.O, East Garo Hills,Meghalaya – 794 108.
(3)Montfort Home,Dhanketi-Malki,Shillong – 793 001,Meghalaya.
- z To include in the Memorandum of the Society that : “Main beneficiaries are the Christian Community and also others”.
